Job Description

The Plant Manager is responsible for multiple production cells, which means leading and controlling the production in those cells concerning safety, quality, delivery accuracy and efficiency. The Plant Manager is also responsible for personnel issues, health, safety and environment, as well as any responsibilities delegated by the Director. The Plant Manager will oversee a workforce of 50+, generally working on weekdays. Manufacturing at this location includes frame manufacturing, plate stamping operations, plate regasketing / gasketing and parts orders in a make to order/make to stock, mixed mode type job shop environment.
